Sub: Third Party Verification work of installed solar systems in 207 remote villages of different districts of Jharkhand under Remote Village Electrification Programme 2011-12 with the help of GPS and Digital Camera.

Preamble

As a part of Remote Village Electrification Programme 2011-12, JREDA invites bid for "Third Party Verification work of 24305 installed solar systems (solar home lighting systems/ solar street lighting systems) as per the Proforma as given at **Annexure-9 to 12** for the village & their households in the 207 remote villages of W.Singhbhum, Palamu, Latehar and Garhwa districts of Jharkhand" for short listing the experienced & eligible Government organization/Autonomous organization/ Non-government organization/ Non-profit organizations to whom work shall be allocated for carrying out the work in a defined time frame. No bidder shall submit bid for quantity less than 2400 systems.

Part -I Technical Bid:

The bidder should fulfill the following minimum technical and eligibility conditions. The bidder should submit the check list for this purpose as per the Proforma given at **Annexure-2.**

- The organization/company should be Government organization/Autonomous organization/Non-government organization/Non-profit organizations with 3 to 5 years similar work experiences carried out for Central/State Government. Copy of incorporation of the organization NGO/NPO should be enclosed with the bid. No subletting of work is allowed.
- 2. The bidder should be a functional organization. To substantiate this claim, the bidder should submit the copy of balance sheet for last 3 years or from the date of establishment to 31.03.2012/31.03.2013, whichever is applicable. The balance sheets should be duly certified by the Statutory Auditor with his stamp.
- 3. Brief background of activities of the organization should be submitted in a separate paper duly signed.

3. **Experience Requirement:**

The Bidder should have cumulative experience of survey/third party verification works of at least **600 items** located in different households across large number of villages/places to any SNA/Govt. organization in the last five years for the smallest lot. (The smallest lot is 10 % of the total nos of installed solar systems whose third party verification work are to be carried out). To substantiate this, the bidder should submit the copy of work order issued to it and corresponding satisfactory completion certificate of such work. The experience claim without both of these documents shall not be acceptable.

4. The bidder should either purchase the bid document from JREDA office by submitting a demand draft of Rs. 1,000/- (Rupees Five thousand only) in favor of "Director JREDA" on any Indian Nationalized Bank/Scheduled Bank, payable at "Ranchi" or may download the bid document from JREDA website (www.jreda.com) and submit the cost of the bid document of requisite value in the form of Demand Draft, as applicable along with Technical Bid Part – I.

5. Bidders should submit in Part – I (Technical Bid) the earnest money in the form of Bank Guarantee/ Demand Draft of requisite value as mentioned in "Particulars of Tender". The Bank Guarantee shall be made in favor of "Director JREDA" payable at Ranchi from any Indian Nationalized bank/Scheduled bank. The bank guarantee shall remain valid for 12 months.

Jharkhand Renewable Energy Development Agency (JREDA), Ranchi invites sealed offers for of RVE projects third partv monitorina from experienced Government Non-Profit organization/Autonomous organization/Non-Government organization/ organization for the mentioned work with your best bidding price offer as per our specifications and terms & conditions mentioned in the bid document. Salient features of the bid document are given below:

1.0 Bid Document

1.1 This bid document comprises of total 24 Pages. In addition, any other documents/instructions/amendments/revisions issued by JREDA on official website (www.jreda.com) till the due date of opening of the bids shall also be deemed to be integral part of the bid document. Failure to furnish all the information as per the bid document in every respect will be at the bidder's risk.

2.0 Cost of Bid Document

- **2.1** Bid document can be purchased from JREDA office by submitting a Demand Draft of Rs. 1,000/- only drawn in favor of "Director, JREDA" on any Indian Nationalized Bank/Scheduled Bank, payable at "Ranchi" of requisite value, as applicable, during the time and period mentioned in "Particulars of Tender".
- **2.2** Bidders may also download the bid document from JREDA website (www.jreda.com) and submit the cost of the bid document of requisite value in the form of Demand Draft, as applicable along with **Part I (Technical Bid).**
- **2.3** Bid applications without the cost of bid document will be rejected.

3.0 Earnest Money

- **3.1** Bidders shall submit in **Part I (Technical Bid)** the earnest money in the form of Bank Guarantee or Demand Draft of requisite value as mentioned in "Particulars of Tender". The Bank Guarantee shall be made in favor of "Director, JREDA" payable at Ranchi from any Indian Nationalized bank/Scheduled bank.
- **3.2** The bank guarantee shall remain valid for 12 months.
- **3.3** The earnest money shall be returned to all unsuccessful bidders, within thirty days from the date of placement of LOI/LOA to the successful bidder(s).
- **3.4** The earnest money shall be forfeited if
 - a. Any bidder withdraws his bid or resiles from his offer during the validity period.
 - b. The successful bidder fails to furnish his Acceptance of the order within fifteen days of placement of LOI/LOA by JREDA.
 - c. The bidder fails to successfully complete the work within the stipulated time frame. Delay in completion due to extreme and unavoidable situations shall have to get approved by Director, JREDA. This approval shall also have a cut-off date by which the entire work shall have to be completed.

4.0 Security Deposit:

4.1 Successful General bidders shall submit a security deposit @10% of the allotted work order value in the form of Bank Guarantee on or before 20 days from issuing work order.

- **4.2** Non submission of Security Deposit within the time frame shall lead to forfeiture of EMD and cancellation of LOI/work order.
- **4.3** If Bidder fails to carry out the work allotted to him as per the provisions of the tender documents then such Bidder may be black listed for future awards of work.

5.0 Submission of Bids:

- 5.1 Bidders are advised to submit their bid strictly based on the specifications, terms and conditions contained in the bid document and subsequent revisions/amendments, if any. The bid should be submitted along with covering letter as given at **Annexure-1**.
- 5.2 The bid shall be prepared and submitted by typing or printing in English on white paper in consecutively numbered pages duly signed by the authorized signatory with company seal affixed on each page. Any part of the bid, which is not specifically signed by the authorized signatory and not affixed with company seal, shall not be considered for the purpose of evaluation. The bidder shall also enclose the information about bidding firm as per **Annexure-2**.
- 5.3 Original copy of bid document, amendments/revisions to bid document and one soft copy, including minutes of meeting(s), issued by JREDA, if any, shall be signed and submitted along with the bid.
- 5.4 All the Proforma must be on the bidder's official letterhead (if specified). Any change in wording of the Proforma will not be allowed. The bidder shall submit a declaration as given at **Annexure-6**.
- 5.5 The offer shall contain no erasures or overwriting except as necessary to correct errors made by bidder. The person signing the offer shall initial such corrections.
- 5.6 Complete bid document including all enclosures should be submitted in hard bond or spiral binding and all pages should be numbered (except leaflet/catalogue) and must be signed by the company's authorized signatory with seal of the company. In absence of any one of these, the offer will be rejected.
- 5.7 The bidders should submit the bid in two envelopes, The Part-I (Technical bid) and the Part II (Price Bid) should be sealed in separate envelopes and both envelopes should be sealed in a third envelope. The Part II (Price Bid) of only such bidders would be opened who qualify in the Part II (Technical Bid). The Part-II (Technical Bid) should be sealed in an envelope super scribed with (i) NIB No. 12/JREDA/TPV/2013-14 (ii) "Part-II Technical Bid", (iii) Name and address of the contact person of the bidding firm, and (iv) should be addressed to Director, JREDA.
- 5.8 **Part –I (Technical Bid)** should not contain price of any item. Such cases, even if found anywhere, shall not be given any cognizance.
- 5.9 The **Part-II (Price Bid)** should be sealed in an envelope super scribed with NIT No., "Part II Price Bid", Name and address of the contact person of the bidding firm, and should be addressed to Director, JREDA. This envelope should contain the following:
 - a. It should contain only Proforma as prescribed at **Annexure-8** duly filled, signed and stamped by authorized signatory of the bidder.
 - In case of any contradiction between the prices mentioned in figures and words, the prices mentioned in words shall be considered final.

- c. The price bid should not contain any technical matter or other matter except price. The date of opening of the price bid will be notified after opening of Technical bid.
- 5.10 Part-I and Part -II of the bid document should be sealed in a third envelope. The third envelope should be sealed and super scribed (i) NIT No., (ii) "Offer for Third Party Verification work of installed solar systems in 207 remote villages of Jharkhand under RVEP 2011-12. (iii) Name and address of the contact person of the bidding firm, and (iv) Should be addressed to Director, JREDA, Plot No. 328 B, Road No. -4, Ashok Nagar, Ranchi-834002.

6.0 Authority of Person Signing the Documents

A person signing the bid document or any document forming part of the bid document shall be deemed to warrant that he has authority to bind such offer/ document and if on enquiry it appears that the person signing the document had no authority to do so, JREDA may, without prejudice to other civil and criminal remedies, cancel the bid/contract and hold the signatory liable for all costs and damages. For this purpose Power of Attorney in the Proforma as prescribed at **Annexure-5** shall be submitted.

7.0 No Claim or Compensation for Submission of Tender

The bidder whose bid is not accepted shall not be entitled to claim any costs, charges or expenses in connection with his submission of bid, even though JREDA may decide to withdraw the Notice Inviting Tender.

8.0 Validity of Offer

Unless otherwise specified, the bidder shall keep his offer valid initially for a period of Six months from the last date of submission of the bid.

10.0 Other Terms & Conditions

- **10.1** Insertion, post-script, addition and alteration shall not be recognized unless confirmed by bidder's signature and stamp.
- 10.2 Incomplete tender or tenders not submitted as per requirement as indicated in the NIT are likely to be rejected.
- **10.3** Bidders shall submit their offer strictly as per terms and conditions of the tender document without any deviation.
- **10.4** If at any time any of the documents/information submitted by the bidder is found to be incorrect, false or untruthful, the bid and/or the resultant order may be summarily rejected/ cancelled at the risk of the bidder.
- **10.5** Failure to furnish all information and documentary evidence as stipulated in the bid document or submission of an offer that is not substantially responsive to the bid document in all respects shall be summarily rejected.
- **10.6** All bids will be received in duly sealed cover within the due date and time. Bids received after the due date and time is liable for outright rejection.
- **10.7** JREDA reserves the right to reject part or whole of the bid/order without assigning any reason thereof, postpone the date of receipt and opening of the bids or cancel the bid without bearing any liability, whatsoever, consequent upon such decision.

- **10.8** No postal transaction shall be entertained for obtaining bid documents.
- **10.9** Issuance of bid documents shall not construe that the bidders would be automatically considered qualified.

<u>General Terms & Conditions</u> NIB No: 12/JREDA/TPV/2013-14

1.0 Introduction

The instruction/information contained in the bid documents are for guidance and compliance of the intending bidder. Bidders are advised to obtain clarification from JREDA, if any, prior to submission of their bid, failing which it will be deemed that the stipulation made in the bid documents have been read, understood and are acceptable to the bidder.

Bidder shall bear all costs associated with the preparation and submission of the bid, journeys undertaken by them and subsequent bidding process till the award of the order to successful bidder and the JREDA shall in no case, shall be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

2.0 Scope of work

The Scope of work for Third Party Verification of solar systems (Solar Home Lighting Systems & Solar Street Lighting Systems) installed in 207 remote villages of Jharkhand shall include the following points for inspection of SPV systems under RVE programme 2011-12:

- 2.1 **Electrification status:** It may be checked whether the villages are also being electrified through grid extension.
- 2.2 **Physical verification:** The number of system in field should tally with those claimed to have been installed. The list of beneficiaries should also coincide.
- 2.3 **Module capacity:** The module capacity for Solar Home Lighting System (SHLS) is 37 W while for Solar Street Lighting System (SSLS) is 74 W. This could be checked by the name plate rating on the modules. It may also be noted whether modules are of the single crystal/poly crystalline/amorphous type.
- 2.4 **Module installation:** Module should be firmly fixed with the roof or on a separate pole. There should be no shadow throughout the day. Orientation should be due south. The angle of inclination should be approximately equal to latitude. The modules should have a colour differentiation mark. Deviations from these should be recorded.
- 2.5 **Fixing of luminaires inside the house**: The luminaires should be firmly fixed. Their positioning should be such that as large a space as possible is illuminated (positioning in a central place is more desirable than positioning on a wall).
- 2.6 **Fixing of cables:** Cables should be firmly fixed and not left loosely hanging.
- 2.7 **Streetlights:** The modules should be shadow free, the lights should be positioned so as to illuminate a well used street, the angle of inclination of the fixture of the lamp should be such that is illuminates the road and not the sky, the pole should be firmly grouted and properly painted.
- 2.8 **Functionality of systems:** The functionality may be recorded.
- 2.9 Arrangement for Annual Maintenance Contract, Servicing and Availability of Spares: Proper and easily accessible arrangements should have been made by

the supplier/implementing agency. The details of the arrangements may be recorded.

- 2.10 Constitution of the Village Energy Committee or other Arrangements for Community Participation: The constitution and actual functionality of the Committee should be noted.
- 2.11 **Monthly payments by the Beneficiaries:** The monthly payments being made by the beneficiaries, if any, may be recorded.
- 2.12 **Satisfaction Level Feedback:** Reaction of the beneficiaries in this regard may be noted. The feedback with respect to the monthly payments, availability of service and spares, etc. may also be recorded.
- 2.13 **Signing of the Report:** The report should be signed by a representative of the Panchayat or of the Village Energy Committee.
- 2.14 The Agency may hire NSS from colleges/Nehru Yuvak Kendra should not belong to the same block of the village/hamlet where the third party monitoring/verification are to be carried out.

3.0 Deliverables:

- 3.1 The third party verification report should be submitted in two hard copies & one soft copy in JREDA office. Two sets of village wise report in separate booklet have to be submitted in the office as per Annexure-9 & 10 along with abstract report of Third Party Verification enumerating clearly the following:
 - Electrification status of village.
 - Details about system installation (module due south facing, inclination of module, fixed on roof top/ pole, proper wiring) with photographs.
 - Details about number systems installed at site under the project village wise in tabular form.
 - The number of systems found functional, non functional, and missing at the time of monitoring by the third party village wise in tabular form.
 - Details of arrangement for O& M by the supplier etc.
 - Training and Awareness camp conducted by the supplier with photographs.
 - Details of Village Energy Committee and their role.
 - Status of monthly contribution by beneficiary.
- 3.2 The Abstract report of the third party verification work village wise as per **Annexure-12 are** also required to be submitted in the office.
- 3.3 The Third Party Verification Report of Solar Home Lighting Systems & Solar Street Lighting Systems should be submitted village wise as per **Annexure-9, 10 & 11** respectively.

4.0 Price

The bidder shall quote his price as per schedule of items of work. The contract price/rate shall be firm and binding and shall not be subject to any variation during the contractual completion period. *The price shall be inclusive of all taxes, duties and levies till validity of the offer.* The price shall also include all cost of labour, conveyance/transport, insurance etc.

5.0 Payment terms and conditions

Subject to any deduction which JREDA may be authorized to make under this contract, the contractor shall be entitled to get payment subject to availability of fund as mentioned hereunder:

- (a) **80%** of the Contract Price shall be paid against submission of data in good condition as certified by Panchayat/VEC officials & JREDA representative after submission of following documents:
 - i. Original Commercial invoice in triplicate (1+2).
 - ii. Copy of duly signed third party verification reports containing details about system installation with photographs (two sets of hard copy and one soft copy)
 - iii. Abstract report of Third Party Verification work village wise in tabular form. .
 - iv. Photographs of Training & awareness camp conducted by Supplier
 - v. Details of arrangements for O&M by the Supplier.
 - vi. Details of VECs and their role.
- (b) Balance 20% of the Contract Price shall be paid after random verification of the data by JREDA representative and to satisfaction of JREDA.

6.0 Liquidated Damages for Delay in Completion

If the contractor fails in the due Performance of the contract to deliver any part of the equipment or complete the work within the time fixed under the contract or any extension thereof granted to him by JREDA and/or to fulfill his obligations in time under the contract, he shall be liable to pay to JREDA @0.5% per week maximum up to 10% of work value delayed beyond contract period.

7.0 Risk & Cost:

If the contractor fails to complete the awarded work up to extended period of one year from the scheduled date of completion then JREDA will be at liberty to cancel the said work order and will get the full or part of left over work to be completed by way of engaging alternate contractor and completion of the said work shall be got completed at risk & cost of the failed contractor and failed contractor shall be liable to pay all the dues to JREDA.

8.0 Assignment/ Sub-letting

The contractor shall not assign or sublet in whole or part, and its obligations to any third party to perform under the order/contract.

In the event the bidder contravenes this condition, JREDA reserves the right to reject the work contract and get the work executed from alternate contractor at bidder's risk and cost. The contractor shall be solely liable for any loss or damage which JREDA may sustain in consequence or arising out of such replacing of the contract work.

9.0 Compliance with Regulations

The contractor shall comply with all applicable laws or ordinances, codes approved standards, rules and regulations and shall procure all necessary municipal and/or

other statutory bodies and government permits & licenses etc. at his own cost. The contractor shall leave Director, JREDA harmless as a result of any infractions thereof.

10.0 Agreement

The successful qualified bidder shall have to enter into an agreement in the office of the Director, JREDA, in prescribed format within 20 days of issue of the work order.

11.0 Income Tax

Without prejudice to the obligations of the contractor under law, any income tax which JREDA may be required to deduct by law/statute, shall be deducted at source and shall be paid to income tax authorities on account of the contractor. JREDA shall provide a certificate for such deductions of tax to the contractor.

12.0 Force Majeure conditions

In the event of either party being rendered unable by force majeure to perform any obligation required to be performed by them under this agreement, relative obligation of the party affected by such force majeure shall be treated as suspended during which force majeure condition last.

The term force majeure shall have herein mean riots (other than among the contractor's employee), civil commotion, war (whether declared or not), invasion, act of foreign enemies hostilities, rebellion, insurrection, military coup to usurp power, act of god such as earthquake, lightening, floods, fires not caused by contractor's negligence and other cause which the contractor has no control and accepted as such by the Director, JREDA, whose decision shall be final and binding.

If the work is suspended by force majeure conditions lasting for more than 45 days, the purchasers shall have the option of canceling this contract in whole or part thereof, at its discretion. The contractor shall not claim for compensation for force majeure conditions.

13.0 Jurisdiction of the Court

All disputes would be settled within Ranchi jurisdiction of court of law only.
