- (ii) The bidder must be in possession of valid Test Report for the LED based Solar Lantern issued by any one of the approved test centers as listed in the NIB.
- (iii) The bidder should have supplied solar photovoltaic systems of the value Rs 1 crores to any State Nodal Agencies / Govt. Organization during the past three financial years and supplies against such work order should have completed satisfactorily as certified by the concerned State Nodal Agencies/ Govt. organization. **(This clause is not applicable to SSI units registered in Jharkhand as well as with NSIC).**

The bidder shall submit (i) attested photocopies of purchase orders / contracts and (ii) the certificate from the concerned State Nodal Agencies for the satisfactorily completion of the work.

- (iv) The bidder should have supplied a minimum 100 nos. LED Based Solar systems and which should have worked satisfactorily for a minimum period of 1 year as on the date of submission of bid. **(This clause is not applicable to SSI units registered in Jharkhand as well as with NSIC).**

The Bidder shall submit attested photocopies of certificates from the respective SNAs / Govt. organization.

- (v) The bidder should be registered under Jharkhand Valued Added Tax Act -2005.
