



Purchase Committee meeting of JREDA held on 27.09.2013 at JREDA Office for evaluation of Technical Bid against NIB NO: 19/JREDA/ST/SWHS/2013-14. Comparative Statement prepared by Tender Committee of JREDA and its recommendations were perused by Committee members.

On the basis documents submitted by bidders and Comparative Statement of Technical Bid prepared by Tender Committee of JREDA views of Purchase Committee of JREDA on their Technical Bids are as follows:


- 1. **M/s Waaree Energies Ltd., Mumbai:** The bidder is a MNRE Channel Partner. The bidder has submitted average annual turnover of last three years ending 31.03.2012 of Rs.124.24 Crore and Net worth as on 31.03.2012 of Rs. 85.52 Crore. As regarding experience criteria the bidder has submitted copy of the supply order at page 92 to page 122 of technical bid but corresponding completion certificate indicating its successful execution has not been submitted. As per NIT, copy of the order and corresponding certificate indicating its successful execution was essentially required to be enclosed otherwise claim for experience will not be accepted. Therefore, based on the documents submitted by the bidder it is recommended that the bidder is **technically not qualified** for opening of Price Bid.
- 2. **M/s Trinity Creations, Ranchi:** The bidder is a MSME of Jharkhand and authorized dealer of M/s Bipin Engineers Pvt. Ltd. (MNRE/BIS approved Manufacturer of SWHS). The bidder has submitted average annual turnover of last three years ending 31.03.2013 of Rs.42.16 Lakh and Net worth as on 31.03.2013 of Rs. 17.41 Lakh. The bidder has submitted copy of the supply order and corresponding completion certificate indicating its successful execution. Therefore, based on the documents submitted by the bidder it is recommended that the bidder is technically qualified for opening of Price Bid.
- 3. **M/s Nitesh Powertech Pvt. Ltd., Ranchi:** The bidder is authorized dealer of M/s Solchrome Pvt. Ltd. (MNRE/BIS approved Manufacturer of SWHS). The bidder has submitted average annual turnover of last three years ending 31.03.2013 of Rs.9.16 Lakh and Net worth as on

31.03.2013 of Rs. 3.58 Lakh. As regarding experience criteria the bidder has submitted copy of the supply order at page 43 to page 57 of technical bid but corresponding certificate indicating its successful execution has not been submitted. As per NIT, copy of the order and corresponding certificate indicating its successful execution was essentially required to be enclosed otherwise claim for experience will not be accepted. Therefore, based on the documents submitted by the bidder it is recommended that the bidder is **technically not qualified** for opening of Price Bid.


4. **M/s Kamla Instruments, Ranchi:** The bidder is a MSME of Jharkhand and authorized dealer of M/s Laxmi Agro Energy Pvt. Ltd. (MNRE/BIS approved Manufacturer of SWHS). The bidder has submitted average annual turnover of last three years ending 31.03.2012 of Rs.1.05 Crore and Net worth as on 31.03.2012 of Rs. 21.12 Lakh. As regarding experience criteria the bidder has submitted copy of the supply order at page 83 to page 147 of technical bid but corresponding certificate indicating its successful execution has not been submitted. As per NIT, copy of the order and corresponding certificate indicating its successful execution was essentially required to be enclosed otherwise claim for experience will not be accepted. Therefore, based on the documents submitted by the bidder it is recommended that the bidder is **technically not qualified** for opening of Price Bid.


