1. Scope of Work:

The scope of works has essentially consist of three parts:

1. Replacement of GLS bulb with 7watt and 10 watt LED bulbs
2. SITC of 60 watt LED street light fittings
3. CMC for 5 years of street lights and warrantee of bulbs

SI. No. Activity Time Period.

1. Replacement of GLS bulb with 7watt and 10 watt LED bulbs and SITC of 60 watt LED street light fittings after signing of agreement within 180 days or specified in pre bid meeting

2. Repair & Maintenance will be up to project period.

General Requirements:

- (i) Bidding agency should submit a Comprehensive Project Implementation Plan (CPIP) with deliverables according to the set timelines along with the technical bid as separate Annexure in terms of number of days.
- (ii) Project office: On award of project, bidding agency will need to open a local project office for the purpose of execution of the project.
- (iii) Bidder is to be ready to install the related work of street lighting system.

2 Eligibility Criteria for Participant:

Participant having following minimum eligibility criteria would be allowed to participate in this Bid:-

2.1.

- (a) Since LED is new technology items, the Bidder should be indigenous Manufacturer of LED Bulb and street light fixtures and have adequate facilities for testing of the complete system or their authorized dealer in Jharkhand having experience in similar work. Bidder should be either original manufacturer of LED or original manufacturer of complete LED Bulb/ Street Lighting systems having LED procured from the list of makes as mentioned in the tender.
- (b) The bidder should submit LED Bulb/Street lights manufacturing certificate issued by competent authority certifying the manufacture of street light fixtures as per specification in case of the authorization as the case may be. The Bidder should submit proof i.e. certificate issued by competent Govt. authority certifying the manufacture of LED Bulb/Street light fixtures.

- (c) LED Bulb and street lighting fixtures of only indigenous make shall be accepted. However, the use of LEDs of reputed foreign make as per make mentioned in NIB is allowed.
- (d) The Bidder shall submit the test report of the quoted products, confirming to the applicable BIS / International Standard & DNIT specifications LM79 and LM80, with the bid, issued by issued by accredited Test laboratories on or after 1st April, 2012. Those manufacturers who have the in-house testing facility i.e. laboratory, approved by the competent Govt. authority, may submit test report of the laboratory along with the copy of the letter approved by the Govt. Authority
- (e) The bidders should have a branch office/service centre in Jharkhand of his own or through its authorized manufacturer. In case bidder does not have their office/service centre in Jharkhand state at present, he shall be required to submit an undertaking for opening a branch office/service centre in Jharkhand state of his own or through its authorized distributor within seven days of agreement against this tender.
- (f) The Average Financial Turnover for Financial Years 2011-12, 2012-13 and 2013-14 should be minimum Rs. 30.00 lacs in the area of LED Lighting Only **for their authorized agency in the area of similar work**. Bidder should submit Audited balance sheet.
- (g) The Net worth of the bidder as on the last day of the year 2014 shall not be less than 10% of quoted amount. **Bidder shall furnish documentary evidence duly certified by chartered account.**
- (h) The bidder should have good track record for supply of quoted items to any Central/State govt. Department/PSUs in the last 03 years i.e. FY 2010-13 and current year and successful supply, installation work in the field of LED Bulb/street lighting business alone in the following manner:
- I. **Three similar individual completed works costing not less than the amount equal to 40% of the quoted amount individually. Or**
 - II. **Two similar individual completed works costing not less than the amount equal to 50% of the quoted amount individually. Or**
 - III. **One similar completed works costing not less than the amount equal to 80% of the quoted amount.**

Definition of similar works: Similar works means supply & installation works for LED Bulb/Street Lights only done individually.

- (i) Bidder shall enclose the copies of purchase orders and Performance/completion certificates for LED Bulb/Street Lights works only for this purpose. The copy of

order and certificate indicating its successful execution should be enclosed with the check list as at **Annexure-2**

- (j) Submit C.A. certificate & Audited Balance sheet in proof of declaration of Turnover.
 - (k) The bidder should not have been debarred from any Central/State Govt. Departments/Agencies/Boards/Corporations/PSUs/ etc.
 - (l) The bidder shall submit the test report(LM 79 and LM 80) of the quoted products, conforming to the applicable relevant BIS/International Standard & specifications, it should be obtained from UL or CPRI or any other NABL certified lab. Test reports of all the quoted items are mandatory, bidder should also give an undertaking in this regard.
 - (m) Valid electrical contractor license issued by Electrical Licensing Board, issued from Energy Department, Govt. of Jharkhand. If the manufacturer does not have Electrical contractor License, prime bidder can submit license of authorized agency of Jharkhand who in this case will be also engaged for installation and CMC work etc. The manufacturer have to give declaration regarding the same.
2. The participant shall be required to have adequate post installation localized service facilities/centers in Jharkhand. In the case firm not having these facilities/centers in the state, the Participant will have to submit a written commitment to establish adequate localized service facilities/ centers within seven days of signing of agreement.
 3. Dealers need to furnish due authorization from the manufacturer signed on the letter head only by an authorized signatory of the manufacturer. Authorizations signed by any other person shall not be accepted and the bid shall be liable for rejection. Dealers shall also have to furnish an undertaking from the manufacturer clearly indicating that the manufacturer shall stand guarantee for the successful of the project including CMC support. Bids without the required **undertaking shall be liable for rejection.**
 4. The Participant should have valid **CST/VAT/PAN/TAN No of Jharkhand State.** Incase the bidder does not have JVAT, then they will have to submit JVAT at the time of agreement.

 6. Please attach authorization letter.
 7. All the material to be supplied shall be subject to Pre Dispatch inspection by JREDA officers as per specification at the cost of Bidder.

1. Bid Document

1.1 Bid documents can be purchased from JREDA office by submitting a Demand Draft of Rs. 5000/- only drawn in favor of "Director, JREDA" on any Indian Nationalized Bank/Scheduled Bank, payable at "Ranchi" of requisite value as applicable, during the time and period mentioned in "Particulars of Tender". - 4.6 Complete bid document including all enclosures should preferably be submitting in hard bond or spiral binding and all pages should be numbered (except leaflet/catalogue) must be signed by the company's authorized signatory with seal of the company.
- 4.7 The bidders should submit the bid in two envelopes, **The Part-I (Technical bid)** and the **Part-II (Price bid)** should be sealed in separate envelopes and both envelopes should be sealed in a third envelope. - 5.3 Bidders shall submit their offer strictly as per terms and conditions of the tender document without any deviation.
- 5.4 If at any time any of the documents/information submitted by the bidder is found to be incorrect, false or untruthful, the bid and/or the resultant order may be summarily rejected/ cancelled at the risk of the bidder.

GENERAL TERMS AND CONDITIONS OF THE CONTRACT

1. GENERAL INSTRUCTIONS:

All the Bids shall be prepared and submitted in accordance with these instructions

- 1.1 The Purchaser reserves the right to request for any additional information and also reserves the right to reject the proposal of any Bidder, if in the opinion of the Purchaser, the data in support of Tender requirement is incomplete.
- 1.2 The Bidder is expected to examine all instructions, forms, terms & conditions and specifications in the Bid Documents and site requirements. Failure to furnish all information required in the Bid Documents or Submission of a Bid not substantially responsive to the Bid Documents in every respect may result in rejection of the Bid. However, the Purchaser's decision in regard to the responsiveness and rejection of bids shall be final and binding without any obligation, financial or otherwise, on the Purchaser.
- 1.3 **The bidders who have purchased the tender document or their authorized representative may participate in the pre-bid meeting for discussion on the tender requirements and for any further clarifications. Such bidders have to furnish their clarification requirements in writing for discussion during the pre-bid. The pre-bid discussion shall be held on 12.08.2014 at 03:00 PM in the office of the Director (JREDA). No further clarifications shall be entertained after the pre-bid meeting.**
- 1.4 The firm will have to produce invoice/gate pass of the manufacturer for major items of material to be installed against supply & erection of work for genuineness of the material.
- 1.5 The Agency shall not assign or sublet the contract without written approval of the JREDA.

2. ENGINEER/PROJECT IN CHARGE

JREDA has nominated an officer, herein after called Nodal Officer, in connection with the implementation of LED Bulb/Street light .

3. VALIDITY

The bidder shall specifically mention the period of validity of the tender/offer. The period of validity shall not be less than **180 days**. If any bidder withdraws his tender before the said period or makes any modifications in the terms or conditions of tender which are not acceptable to EIC, then the earnest money shall be forfeited without prejudice to any other rights of the tendering authority.

4. EXECUTION AND COMPLETION

The project including supply, erection and handing over in all respect should be completed within **90 days** which will be reckoned from the date of issue of purchase order and time of completion will be worked out accordingly. However, "time" being the essence of the project, early completion shall be highly appreciated.

Failure to complete the project within stipulated time period shall attribute towards Penalty as per relevant Clause mentioned in this Tender Specification except in force majeure conditions as per the tender

5. CONSIGNEE:

The Jr. Engineer or appropriate authority as designated by the Nodal Officer (JREDA) shall be the consignee for the materials to be supplied under the work. The list of consignee along with other details shall be specified during placing formal orders.

6. PERFORMANCE SECURITY:

The successful bidder shall be required to submit a performance security in shape of Bank Guarantee (BG) executed on non-judicial stamp paper worth Rs.100/- (Rupees One hundred only) issued by a Nationalized / Scheduled Bank in favour of the Director, JREDA of 10% of the total order value. Validity of BG will be 60 months as per the format enclosed in **Appendix-9**. This bank guarantee shall be released after satisfactory completion of the CMC. The BG should be accompanied by a confirmation letter from the concerned bank.

- If the project completion period is delayed, the firm shall further extend the BG to cover the delay period. No interest is payable on the Performance Guarantee.
- The Performance Guarantee will be discharged after completion of the obligations by the bidder under the contract.
- In case of non-fulfillment of contractual obligation, the Performance Guarantee shall be forfeited.
- Any claim out of the liquidated damages may be recovered from the performance security.

7. EXECUTION OF AGREEMENT:

Within 15 days from the date of issue of purchase order by JREDA, the successful bidder shall sign and execute the contract agreement with the JREDA . The agreement shall be executed in Ranchi stamp paper worth Rs100/-.

 - (ii) Copy of dully raised delivery Challan/transport challan/lorry receipt/dispatch clearance.
 - (iii) Duly filled Annexure-II in three sets (one for Consignee record, one for JREDA HQ. and one for Engineer-In-Charge of the work).
 - (iv) Photographs of all the equipments (materials) at destination with signature & seal of Consignee & JREDA officials along with register to be maintained as per direction of Engineer-In-Charge for verification.
- Rest 10% of the Contract price shall be paid @ 2% per annum after completion of warranty period.

- 60% of the Contract price against supply and delivery of goods in full and in good condition as certified by Consignee & JREDA officials after submission of following documents:
 - (i) Original Commercial invoice raised from the state of Jharkhand for the supply made in triplicate (1+2).
 - (ii) Copy of dully raised delivery Challan/transport challan/lorry receipt/dispatch clearance.
 - (iii) Duly filled Annexure-II in three sets (one for Consignee record, one for JREDA HQ. and one for Engineer-In-Charge of the work).
 - (iv) Photographs of all the equipments (materials) at destination with

signature & seal of Consignee & JREDA officials. This record should be kept in the office of Engineer-In-Charge for verification.

- 30% of the Contract price shall be paid against successful installation, testing & commissioning after submission of following documents:
 - (i) Certificate for minimum seven days of satisfactory performance duly certified by the Consignee & JREDA officials.
 - (ii) Photographs of all the equipments after installation at destination with signature & seal of Consignee & JREDA officials. This record should be kept in the office of Engineer-In-Charge for verification.
- Rest 10% of the Contract price shall be paid @ 2% per annum after satisfactory completion of CMC period.

9. WARRANTEE:

10. PENALTY FOR DELAY IN COMPLETION OF CONTRACT:

The time for and date of delivery or dispatch & commissioning stipulated in the work order shall be deemed to be the essence of the contract, and if the firm fails to complete the works on the scheduled period or any extension granted thereby, the firm shall be liable for payment of penalty amounting to 0.5% (half percent) of

The CMC service shall include quarterly examination of the installation during regular working hours by trained persons in consultation with JREDA authorities and shall include all necessary supplies and genuine standard parts to keep the. Street lighting and the controllers are in proper working order. The call back should also be attended immediately.

15. EXTENSION OF TIME:

If the delivery of the equipments / materials is delayed due to reasons beyond the control of the Firm, the Firm shall apply to the JREDA in writing of his claim for an extension of time under intimation to Director JREDA

16. SAFETY PRECAUTIONS:

The firm shall observe all applicable Rules and regulations regarding safety at the Site. Any compensation due on account of accident at site shall be responsibility of the site to the firm.

17. AUTHORITY FOR ACCESS:

No persons other than the employees of the Firm and his sub-firms shall be allowed on the Site except with the written consent of JREDA or EIC. Facilities to inspect the work shall at all times be afforded by the firm to EIC.

18. ENGAGEMENT OF LABOUR:

The Firm shall make its own arrangements for the engagement of all labour and for their payment, housing, feeding and transport. The agency shall have a valid electrical contractor license issued by ELBO, Jharkhand. The Firm shall be solely responsible for the safety of the labour and equipments during execution of the project and shall adopt all safety measures as per applicable rules in force.

19. STORE:

The storing of materials at work site shall be arranged by the firm at its own cost. No compensation shall be made by the JREDA for any damage or loss of materials during storing, transit transportation and at the time of erection. The firm has to ensure necessary safety and insurance during the storage and during installation of the project.

20. INSURANCE:

21.0 Force Majeure conditions

In the event of either party being rendered unable by force majeure to perform any obligation required to be performed by them under this agreement, relative obligation of the party affected by such force majeure shall be treated as suspended during which force majeure condition last.

The term force majeure shall have herein mean riots (other than among the contractor's employee), civil commotion, war (whether declared or not), invasion, act of foreign enemies hostilities, rebellion, insurrection, military coup to usurp power, act of god such as earthquake, lightening, floods, fires not caused by contractor's negligence and other cause which the contractor has no control and accepted as such by the Director ,JREDA, whose decision shall be final and binding.

If the work is suspended by force majeure conditions lasting for more than 45 days, the purchasers shall have the option of canceling this contract in whole or part thereof, at its discretion. The contractor shall not claim for compensation for force majeure conditions.

2.1 CONSTRUCTION

The lamps should be robustly built with adequate mechanical strength, heat resistance, insulation resistance, flame resistant and corrosion resistant material complying with relevant clauses of IS 16102.
