CORRIGENDUM NOTICE

- 1. A minimum lot size has been introduced in Chapter 1 (Bid Details) of the NIB on Page 3. Bidders are requested to quote as per the lot size mentioned below:**

- (a) Lot-I: Quantity of SHLS -3817 Nos. ; Quantity of SSLS-380 Nos.
- (b) Lot-II: Quantity of SHLS -7723 Nos. ; Quantity of SSLS-770 Nos.
- (c) Lot-III: Quantity of SHLS -11617 Nos. ; Quantity of SSLS-1158 Nos.
- (d) Lot-IV: Quantity of SHLS -15580 Nos. ; Quantity of SSLS-1468 Nos.
- (e) Lot-V: Quantity of SHLS -20343 Nos.; Quantity of SSLS-1800 Nos.

The bidders may quote for any of the lot sizes as per their suitability.

Bidders may also quote separately for Lot-VI where SHLSs required to be supplied would be without the charge controller, CFL circuitry & CMC. These SHLS systems would be installed by the Villagers trained by Barefoot College and Tilonia / NIRD, Hyderabad. However, complete set of SSLS systems would be required to be supplied including 5 years CMC under the Lot-VI. Under Lot-VI, SHLS and SSLS systems requirement is 2251 Nos. and 226 Nos. respectively.

- 2. EMD in Chapter 1 of the NIB on Page 3, serial no. 8 should be read as follows: Earnest Money required to be paid by bidders Lot wise are as under:**

- 3. Time of Completion in Chapter 1 of Page 3 should be read as 4 months.**
- 4. Clause 7.5 of Page 8 should be read as "Bidder may submit their offer as per the lot size mentioned above in corrigendum notice.**
- 5. Clause 12.0 VII of Page 9 should be read as "The intending bidders quoting for the Lot-V should have supplied solar photovoltaic systems of the value of at least Rs. 7.0 Crores to any State Nodal Agency/Govt. organization during any one of the financial year 2009-10, 2010-11 & 2011-12. The bidders quoting for the Lot IV, III, II & I should have supplied solar photovoltaic systems of the value of at least Rs. 5.0 Crores, 3.5 Crores, 2.5 Crores & 1.25 Crores respectively to any State Nodal Agency/Govt. organization during any one of the financial year 2009-10, 2010-11 & 2011-12. The bidders quoting for the Lot-VI should have supplied SPV systems of the value of at least Rs. 0.55 Crores to any State Nodal Agency/Govt. organization during any one of the financial year 2009-10, 2010-11 & 2011-12. This clause is not applicable for SSI Units located and registered in Jharkhand as well as with NSIC.**
