#### 1. BACKGROUND INFORMATION

#### 1.1 The Energy Conservation Act, 2001

The Energy Conservation Act, 2001 (ECA) forms the core of the legal framework put in place by India to promote energy efficiency and conservation. ECA came into force with effect from March 1, 2002.

#### Objectives of the EC Act - 2001

- Provide a policy framework and direction to national energy conservation activities.
- Coordinate policies and programs on efficient use of energy with stakeholders.
- Establish systems and procedures to verify measure and monitor EE improvements.
- Leverage multilateral, bilateral and private sector support to implement the EC Act.
- Demonstrate EE delivery systems through public-private partnerships.
- To promote energy efficiency in the country.

#### **Thrust Areas of EC Act**

- Establishment of BEE.
- Establishment of State Designated Agencies.
- Identification of Designated Consumers.
- Energy Conservation Building Code.
- EE in Govt. Buildings & Establishments
- DSM in Power Sector & Agriculture Sector
- Standards & Labeling Program
- Energy Managers & Auditors
- Establishment of EE Delivery Service Mechanism (ESCO)
- Policy Research in the area of Energy Efficiency.

### 1.2 About Jharkhand Renewable Energy Development Agency (JREDA)

Jharkhand Renewable Energy Development Agency (JREDA) is established as the State Designated Agency (SDA) by State Government under section 15(d) of the EC Act.

The following are the activities where JREDA is involved in relation to Energy Efficiency activities:

- Implementation and monitoring of energy efficiency projects.
- Promote new energy efficient technologies like LEDs etc.
- Coordinating energy efficiency activities with State Govt. departments of Urban Development,
   Municipalities, Electricity and Industry.

- Capacity building to carry out inspection functions under EC Act and provide the basis for penal actions by adjudication, wherever necessary.
- Get an energy audit conducted by an accredited energy auditor in the specified manner and intervals of time.
- Comply with energy consumption norms and standards, and if not so, to prepare and implement schemes for efficient use of energy and its conservation.
- Prescribe energy conservation building codes for efficient use of energy and its conservation in commercial buildings State Governments to amend the energy conservation building codes to suite regional and local climatic conditions.
- Specify energy consumption standards for notified equipment and appliance.

The financial support to the SDA for the energy efficiency work and related projects is given by the State Govt. along with Bureau of Energy Efficiency (MoP).

#### 1.3 About BEE

The mission of Bureau of Energy Efficiency (BEE) is to develop policy and strategies with a thrust on self-regulation and market principles, within the overall framework of the Energy Conservation Act (EC Act), 2001 with the primary objective of reducing energy intensity of the Indian economy. This will be achieved with active participation of all stakeholders, resulting in accelerated and sustained adoption of energy efficiency in all sectors. The setting up of Bureau of Energy Efficiency (BEE) provides a legal framework for energy efficiency initiatives in the country. The Act empowers the Central Government and in some instances the State Governments too for:

- 1. Notifying energy intensive industries, other establishments, and commercial buildings as designated consumers.
- 2. Establish and prescribe energy consumption norms and standards for designated consumers.
- Direct designated consumers to designate or appoint certified energy manager in charge of activities for efficient use of energy and its conservation.
- Get an energy audit conducted by an accredited energy auditor in the specified manner and intervals of time.
- **5.** Furnish information with regard to energy consumed and action taken on the recommendation of the accredited energy auditor to the designated agency.
- **6.** Comply with energy consumption norms and standards, and if not so, to prepare and implement schemes for efficient use of energy and its conservation.
- 7. Prescribe energy conservation building codes for efficient use of energy and its conservation in commercial buildings State Governments to amend the energy conservation building codes to suit regional and local climatic conditions.
- **8.** Direct owners or occupiers of commercial buildings to comply with the provisions of energy conservation building codes.
- 9. Direct mandatory display of label on notified equipment and appliances.
- **10.** Specify energy consumption standards for notified equipment and appliance.
- **11.** Prohibit manufacture, sale, purchase and import of notified equipment and appliances not conforming to standards.

#### **Definitions**

Unless the context otherwise requires, the following terms whenever used in this EOI and Agreement have the following meanings:

- a. "Applicable Law" means the laws and any other instruments having the force of law in India as they may be issued and in force from time to time.
- b. "Proposals" means proposal submitted by respondents in response to the EOI issued by Jharkhand Renewable Energy Development Agency (JREDA), on behalf of Government of Jharkhand for engagement of Auditors.
- c. "Competent Authority" means the Director or Management committee headed by
   Chairman-cum-Principal Secretary, Energy Department and Government of Jharkhand as the case may be.
- d. "Committee" means Purchase committee constituted for evaluation of the EOI.
- e. "Bidder" means the Agency on the panel drawn up in pursuance of this EOI, which will provide the services to JREDA.
- f. "Agreement" means the Agreement signed by the parties for engagement along with the entire documentation specified in the EOI.
- g. "Day" means Calendar day.
- h. "Effective date" means the date on which the empanelment comes into force and effect.
- i. "ITR" means Instructions to Respondents, specified in Section II of EOI
- j. "IFP" means Invitation for Proposals, specified in Section I of EOI
- k. "Government" means the Jharkhand State Government.
- I. "JREDA" means Jharkhand Renewable Energy Development Agency.
- m. "Personnel" means professional and support staff provided by the Bidder detailed to perform services to execute an assignment and any part thereof.
- n. "SOW" means Scope of Work for the Respondents, specified in Section III of EOI.
- "Services" means the work to be performed by the Bidders pursuant to the selection by JREDA and to
  the agreement to be signed by the parties in pursuance of any specific assignment awarded to them by
  JREDA.
- p. "Proposal" means the technical bid submitted by the applying firm for the empanelment process, which includes only Annexure-1 to Annexure 11.

#### 1. Introduction

The Ministry of Power has launched the National Awareness Campaign in order to promote energy conservation in the country. Energy Conservation Act 2001 mandates Central Government and State Government to take all measures necessary to create awareness and disseminate information for efficient use of energy and its conservation. Bureau of Energy Efficiency (BEE), New Delhi and Jharkhand Renewable Energy Development Agency (JREDA) is entrusted with the task to implement such schemes as mandated. National/State Energy Conservation Awards, Painting Competition, Elocution Competition, Essay Competition on energy conservation for students, and awareness scheme are such a few attempts is undertaking to create awareness about energy efficiency and its conservation.

Capacity building of Students is a scheme, BEE is undertaking during the XII five-year plan. Establishment/strengthening the energy clubs for schools has been included as one of the activities this scheme. This activity would not only make aware the children about the need of conserving energy but at the same time would educate and involve their parents as well in the above cause. The identified activity is one of the measures, which can help in creating awareness in the domestic sector

#### 2.1 Conflict of Interest

JREDA requires that the Bidders should provide professional, objective, and impartial advice purely based on standard and accepted technical norms and at all times hold the JREDA's interest's paramount, strictly avoid conflicts with other assignments/jobs or their own corporate interests and act without any consideration for future work. The norms should be based on sound engineering principles guided by all connected codes and guidelines issued from time to time by central and state authorities.

#### 2.2 Validity of Proposals

Proposals shall remain valid for the period of engagement as prescribed in EOI. A Proposal valid for shorter period may be rejected as non-responsive.

### 2.3 Right to accept Proposal

JREDA reserves the right to accept or reject any Proposal, and to annul the Engagement process and reject all Proposals at any time prior to the signing of the agreement, without thereby incurring any liability to the affected Respondent(s) or any obligation to inform the affected Respondent(s) of the grounds for such decision.

#### 2.4 Fraud and Corruption

JREDA requires that the Bidder shortlisted through this RFP must observe the highest standards of ethics during the performance and execution of such agreement. In pursuance of this policy, JREDA:

- (a) defines, for the purposes of this provision, the terms set forth as follows:
  - i. "Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of JREDA or any personnel of Bidder(s) in contract executions.
  - ii. "Fraudulent practice" means a miss-presentation of facts, in order to influence a procurement process or the execution of a contract, to JREDA, and includes collusive practice among Respondents (prior to or after Proposal submission) designed to establish Proposal prices at artificially high or non-competitive levels and to deprive JREDA of the benefits of free and open competition;
  - iii. "Unfair trade practices" means supply of services different from what is ordered on, or change in the Scope of Work which was given by the JREDA in Section III.
  - iv. "Coercive practices" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the execution of contract.

- b) JREDA shall reject a proposal for award, if it determines that the Respondent recommended for award, has been determined by JREDA to having been engaged in corrupt, fraudulent or unfair trade practices.
- c) JREDA shall declare a Bidder ineligible, either indefinitely or for a stated period of time, for awarding the contract, if it at any time determines that the Bidder has engaged in corrupt, fraudulent and unfair trade practice in competing for, or in executing, the contract.

#### 3. Clarifications and amendments of RFP Document

#### 3.1 RFP Clarifications

During technical evaluation of the Proposals, JREDA may, at its discretion, ask Respondents for clarifications on their proposal. The Respondents are required to respond within the time frame prescribed by JREDA.

#### 3.2 Amendments in RFP

At any time prior to deadline for submission of proposal, JREDA may for any reason, modify the RFP. The prospective Respondents having received the RFP shall be notified of the amendments through website and such amendments shall be binding on them.

#### 4. Process for Engagement of Respondents

JREDA intends to Hiring Agency for Establish Energy Club at 50 numbers of Govt. School and conduct orientation training of the school teacher in the State of Jharkhand under "School Capacity Building Program by Bureau of Energy Efficiency"

#### 5. Eligibility Criteria

The Bidders must meet the following eligibility criteria:

#### Turnover:

Annual turnover must be at least Rs. 15, 000, 00/- per year during last three years from Energy consulting Services derived from the last three financial years ending on 31.03.2016/2017/2018 on the basis of audited annual accounts. (Proof to enclose)

### Experience:

Bidder / Agency must have experience of at least 3 years in conducting Energy Conservation/Energy Efficiency awareness training/workshop program or School Building capacity program with Central/State Govt./PSU/private sector.

\*(Copy of the work completion Certificates needed to be enclosed by the Bidder while applying for the Tender)

#### 5.1 Disqualifications

JREDA may at its sole discretion and at any time during the evaluation of Proposal, disqualify any Respondent, if the Respondent has:

- a. Submitted the Proposal documents after the response deadline:
- b. Made misleading or false representations in the forms, statements and attachments submitted in proof of the eligibility requirements;
- c. Submitted a proposal that is not accompanied by required documentation or is non- responsive;
- d. Failed to provide clarifications related there to, when sought;
- e. Submitted more than one Proposal;
- f. Declared ineligible by the Government of India/State/UT Government for corrupt and fraudulent practices or blacklisted.

#### 6. Preparation of Proposal

The Respondents shall comply with the following related information during preparation of the Proposal-

- a) The Proposal and all associated correspondence shall be written in English and shall conform to prescribed formats. Any interlineations, erasures or over writings shall be valid only if they are initialed by the authorized person signing the Proposal.
- b) The Proposal shall be typed or written in indelible ink (if required) and shall be signed by the Respondent or duly authorized person(s) to bind the Respondent. **The letter of authorization** shall be indicated by authenticated Power of Attorney and shall accompany the Proposal.
- c) In addition to the identification, the covering letter (Form 1) shall indicate the **name and address** of **the Respondent** to enable the proposal to be returned in the case it is declared late, and for other purposes.
- d) Proposals received by facsimile shall be treated as defective, invalid and rejected. Only detailed complete proposals in the form indicated above received prior to the closing time and date of the proposals shall be taken as valid.
- e) Respondents are not permitted to modify, substitute, or withdraw Proposals after its submission.

- a) A brief description of the firm and an outline of the relevant past experience on assignments and highlighting experiences on implementation of Energy Audit projects in the format given in Form.
- b) The composition of the team of personnel which the Bidders would propose to provide with the details of name of the personal, his/ her area of expertise, position and the tasks which would be assigned to each team member.
- c) Curricula Vitae of the individual staff members to be assigned to the work and of the senior officer in the home office who would be responsible for supervision of the team. The curricula vitae should follow the attached Format.
- d) JREDA reserves the right to verify all Statements, information and documents, submitted by the Bidder in response to the RFP. Failure of JREDA to undertake such verification shall not relieve the Bidder of its obligations or liabilities hereunder nor will it affect any rights of JREDA there under. In case it is found during the evaluation or at any time before signing of the Agreement or after its execution and during the period of subsistence thereof, that one or more of the eligibility conditions have not been met by the Bidder or the Bidder has made material misrepresentation or has given any materially incorrect or false information, the Bidder shall be disqualified forthwith if not yet appointed as the consultant either by issue of the LOA or entering into of the Agreement, and if the Bidder has already been issued the LOA or has entered into the Agreement, as the case may be, the same shall, notwithstanding anything to the contrary contained therein or in this RFP, be liable to be terminated, by a communication in writing by JREDA without JREDA being liable in any manner whatsoever to the Bidder or consultancy, as the case may be.

In such an event, JREDA shall forfeit and appropriate the Bid Security as mutually agreed pre-estimated compensation and damages payable to JREDA for, inter alia, time, cost and effort of JREDA, without prejudice to any other right or remedy that may be available to JREDA.

#### 7.4 Form II: Financial Proposal - details

- Evaluation Method: It will be Quality cum Cost Basis Selection (QCBS). Bids of all Bidders shall be evaluated based on the above-mentioned criteria to arrive at a Technical Score for Each Bidder. #### 18 Compliance with Regulations
